# Adoption Issues Clarified at Residents' Group Meeting

The last meeting of the Ram's Residents' Group was held on 7th July and was well attended with 29 motivated residents squeezing into a classroom at Churchers College to discuss the important issues that affect us as a community. Chief amongst these, without doubt, was the ongoing debate about adoption of the estate by local authorities and we were fortunate to have newly-elected County Councillor Vaughan Clarke in attendance to explain some of the history to the current situation and to help us take the matter forward.

A number of issues were discussed at the meeting and these, along with the agreed actions, are recorded in the minutes, which will be made available at the next meeting on 3<sup>rd</sup> November. Discussion was dominated. however, by previously reported concerns that residents could find it difficult to sell their properties due to the Planning Contravention Notice placed on the developer (Taylor Wimpey) by East Hampshire District Council due to non-completion of the cycle-link to Ramshill along Skinners Lane. This issue had become linked in our minds, over time, with a collective desire to see the estate adopted by the local authority, however Councillor Clarke (having been a Town Councillor for a number of years, a previous Mayor and now County Councillor) was able set us straight on what had previously been agreed and what could possibly happen in the future. Adoption of the estate falls into 3 categories:

- 1. Roads & Lighting. The intention is for these to be adopted by Hampshire County Council once agreement has been reached with the developer that they are at the required standard. Previous indications were that both parties were close to agreeing transfer of responsibility.
- 2. <u>Surface Water Drainage</u>. The intention is for Southern Water to assume responsibility for this, however disagreements regarding the suitability of the overflow arrangements adjacent to Kingsfernsden Lane mean that responsibility remains with Taylor Wimpey until agreement can be reached.
- 3. <u>Green Spaces.</u> Taylor Wimpey have contracted a company called "Greenbelt" to look after those areas that are not the responsibility of either

Drum Housing or Petersfield Housing Association. Whilst this arrangement can stay in place indefinitely, Taylor Wimpey have previously approached Petersfield Town Council with a view to transferring a suitable sum of money to pay for the Council to take on this responsibility; unfortunately agreement could not be reached on the sum required, but Taylor Wimpey remain keen to transfer responsibility to either the Town or District Council. Residents are concerned that we could become liable for funding this service if Taylor Wimpey should go out of business without transferring responsibility for green areas to either local authority.

Separate to these issues is non-completion of the planned cycle path along Skinners Lane, connecting the estate with Ramshill; this has run into difficulties due to the unstable nature of the walls on either side and opposition from adjoining property owners. East Hampshire District Council has the lead on local planning issues and has served a Planning Contravention Notice on Taylor Wimpey as a first step towards solving the problem.

To try and bring all these issues to a satisfactory resolution, the Rams Residents' Group Committee contacted Cllr Clarke, who attended our Residents' Group meeting on the 7<sup>th</sup> July. Since the meeting, Cllr Clarke has been able to confirm that the developer has submitted revised plans for Skinners Lane, which have been approved by EHDC. These plans involve building a footpath rather than a cycleway, which (being narrower) will allow for the construction of retaining walls on either side to overcome the danger posed by the unstable nature of the existing walls. Details of high-level lighting and timescales for construction remain to be agreed. The surface water drainage scheme has also been approved, which paves the way for its adoption by Southern Water and adoption of the roads by Hampshire County Council. Thanks Vaughan!


