Update on Estate Adoption Issues

It won't have escaped your attention that despite the optimism noted in our last newsletter in May, work still has not started on the foot / cycle path in Skinners Lane. which means that efforts are still ongoing to get the estate adopted by local authorities. Councillor Vaughan Clarke has kept residents up to date with progress and issues at the Residents' Group meetings held in May and September and explained that despite revised plans for Skinners Lane having been approved by East Hampshire District Council (EHDC), the planning authority, Hampshire County Council had refused to take responsibility for the final design as they did not consider that it provided sufficient protection from danger of masonry falling off the unstable boundary walls to the properties in Hoggarth Close. It also appeared that Southern Water had become reluctant to accept responsibility for the estate's drainage system from Taylor Wimpey, even though EHDC had finally approved the design.

Faced with this impenetrable stand-off between local authorities and the developer, the Rams Residents Group committee decided to bring the matter to the attention of Damian Hinds the recently elected MP for East Hampshire, having previously received assistance from his predecessor, Michael Mates. At a constituency surgery on 16 July, Chris Burgess, Dean Leverett and Gaile Gould sat down with Mr Hinds to explain the history of the situation and the detrimental effect that non-adoption is having on residents who are trying to sell their properties on the estate. The MP agreed to look into the matter to see if there is anything he can do to help bring about a solution and to date we have received the following updates on his progress:

7 Sep – Mr Hinds wrote to Mr A J Sturla, Managing Director of Taylor Wimpey: "I note the current impasse and wonder if you think it would be helpful for me to arrange a meeting with you and representatives of the County Council and Southern Water to try and find a way forward."

16 Sep – Mr Sturla replied: "we would be delighted if you could help to arbitrate in this matter I will ask Nigel Phillips to arrange a meeting so that all parties can attend."

Sewage -adopted

11 Nov - Mr Hinds assistant e-mailed Chris Burgess with: "I have just spoken on the telephone to Nigel Phillips who was charged with organising the proposed meeting. He tells me that, as soon as he suggested the meeting to Southern Water, they decided they could sign the necessary agreement with Taylor Woodrow and this is now being arranged through the respective legal departments. As soon as the agreement is signed, Mr. Phillips will be in touch with the County Council re the roads and Skinners Lane. Mr. Phillips has also promised to keep up the pressure if needed to get the agreement signed but hopes this will soon be done now. He is going to email Damian with any news. So, at the moment, it seems the meeting is not necessary but Damian has told Mr. Phillips to let him know if there is any hiccup with the signing or with the County Council so he can intervene to try to help further."

In parallel with this approach, given recent focus regarding planning applications for four further new housing developments in Petersfield. was decided to apply pressure through the local press planning and at consultations with the developers the proposed new estates. On 21 July it was the lead



story in the Petersfield Post, focussing on concerns over what would happen to Ramshill if Taylor Wimpey were to get into financial difficulty. Despite the alarmist headline, response to the article has been positive and it has helped remind local planning officials that developers' promises of environmentally friendly links with the town's transport networks do not necessarily materialise as planned and might not be good reasons to approve proposed plans.

If you have any views on the adoption situation, suggestions as to how you think it should be taken forward or particular skills or contacts that could help us find a way towards a timely solution, then please come along to the next Residents' Group meeting on 30 November and help make a positive contribution to your


