Planning Agenda for Trademark House: You may be aware a planning application by Taylor Wimpey has been submitted to demolish the commercial building next to Esso and build "22 residential dwellings" and "one commercial unit". Your residents' association will be submitting a formal objection and all residents are free to voice their views on the South Downs National Park Planning Portal.
